The following concerns were raised and will be reported to the appropriate authority;

- At the top of Derby Road (near the traffic lights) the cut down tree has been left at the side of the road and is causing an obstruction.
- Coxbench Road There are temporary traffic lights in place and lots of litter in the verges.
- Smalley Mill Road needs a clean-up and the road markers reinstating.
- There is a hole appearing in the middle of Coxbench Road (opposite Sunnymead).
- Coxbench Road There is still a need for a weight limit to be placed on the road. Lorries are
 taking away the verge and there is a hole/collapse at the side of the road, together with lots of
 vegetation on the pavement. Signage is required to warn users and a road sweeper to remove
 the vegetation from the pavement, as the fallen vegetation has made the pavement very narrow.
- Footpath near the Rockety A walker nearly fell over due to the unevenness of the surface.
