Flooding

Footpaths

FP22 runs along the stream parallel to Coxbench Road and is impassable with vegetation. Photographs have been taken and reported to Derbyshire County Council, the case reference number is FS-Case-542084400.

Road Signs

The road signs on Coxbench Road and Sandy Lane have now been replaced.

Trees

The new oak tree continues to grow nicely together with the trees on the recreation ground.

The overhanging branches on Coxbench Road between Sandy Lane and Horsley Lane which have previously been reported have still not been cut back. This is causing passing lorries to catch the branches which then fall into the road.

Village Hall

Horsley Village Hall Auction took place on Sunday 10th September 2023 at the Coach and raised around £1,100, which will help towards repaying the loan on the Village Hall.

The Race Night is due to be held on Friday 13th October 2023, this event is always well supported. The Village Hall Caretaker now has 10 weekends off per year and members of the committee are volunteering to cover the caretaker's duties. If there are no volunteers this means a reduction in the ability to offer the hall throughout those weekends. The issue will be discussed at the Village Hall Meeting on the 24th October 2023. Otherwise, both regular bookings and occasional bookings continue to be healthy.

The Clerk has continued to update the website and it is hoped that Councillor M Beasley and Councillor J Holden will be able to have a finished version of "What your Parish Council does for you" ready to go live on the website after the October Parish Council Meeting.
