23/231 Public Speaking

The following concerns were raised and will be reported again to the appropriate authority;

- Coxbench Road (outside Sunnymead) there is a large hole in the road.
- Horsley Lane (outside Burn Brae) there is a large pothole.
- Smalley Mill Road (towards the golf club) on the right hand side there is a large pothole and the tarmac has broken in places.
- Coxbench Road there is still serious concern regarding the road surface and heavy vehicles using the road. Due to the narrowness of the road, the heavy vehicles are having to drive close to the edge of the road, which is causing the road surface to fall away. A weight restriction on the road would help resolve this problem and prevent an accident occurring.
- Horsley Lane the drains at the bottom of the lane (A38 end) still need to be cleared as it is causing flooding.
- Horsley Lane (Rock Cottage) the flagstones along the path are uneven which makes the path difficult to walk down.
- Tants Meadow there are two large potholes.

Agreed: The Clerk to chase the relevant authority and log an urgent report with Derbyshire County Council regarding the request for a weight limit on Coxbench Road.

Comment:

Horsley Parish Council wish to make the following comments regarding this application:

1. The Parish Council strongly supports the observations/comments already submitted by local residents.

2. The whole of the land of Horsley Hall (including the field where the proposed building would be built) is in the Horsley Conservation Area.

3. The building of a building such as a storage barn in a Conservation Area would set a precedent for further development. This would have a devastating effect of the landscape.

4. No trees should be felled within the Conservation Area, as to do so would change the landscape forever.

5. There would be a highways issue due to the lack of adequate infrastructure to allow vehicular access to the location.

6. Horsley Hall is a private residence with no farming activity taking place.

7. Noise pollution is also of great concern.
